1. Call to Order

Mr. McGrail called the meeting to order at 10:10AM. Ms. Ward-Jackson kept a record of the proceedings.

4. Quarter 1-2023 Financials – Eric Piurkowski, CPA CFO

Mr. Piurkowski began discussing the balance sheet portion of his financials through 03/31/2023, a copy had been distributed to all; and a copy is included within these minutes. Mr. Piurkowski stated that as of 03/31/2023 we had \$680K in Clinton Savings Bank at quarter end, total cash and cash equivalents were \$1. He continued by stating that there is \$10.6M in bonds and \$7.5M in equities. Mr. Piurkowski continued stating that the premium receivable is \$255,958. Mr. Piurkowski also stated that the total assets are \$19.6. He then reviewed the profit & loss portion of his financials in detail and answered questions from Committee Members.

A *motion* was made by Mr. Zorola to accept the unaudited financials as presented; Mr. Robertson seconded the motion. It passed unanimously.

He began discussing recent headlines, Global Re-Alignment/U.S. Internal Conflict; New U.S. Monetary/Fiscal Regimes = Recession?; MRP Assets Balanced. He reviewed the market changes and global equity markets. Mr. Bacon continued reviewing his handout and noted what to expect; Acrimony and Brinkmanship; Short-Term equity decline; government bond and US dollar rally. He answered questions from Governing Committee members.
